For budgeting purposes, PI's should assume a 5% increase on July 01 each fiscal year.

The listed rates include standard husbandry practices. Rates for projects requiring additional services (e.g., BSL-2 containment, barrier housing, GLP, etc.) may differ significantly and consultation with Animal Resources is recommended to establish a budget. Rates are subject to review & revision in January and July of each year. Per diem is defined as the expenses required to maintain an animal or box of animals (mice) for any portion of a calendar day.

- A** Charges will be made to the UGA Principle Investigator requesting the animal shipment. It is up to the PI to recoup cost from the receiving collaborator.
- B** Charges for procedures which are not part of standard husbandry or animal care. This list includes, but is not limited to, procedures such as breeding, weaning, sample collection (tail clipping, ear clipping, blood collection), and identification (microchipping, ear punches)
- C** Charges apply for all animal order changes or each transfer event. Transfer events are: (1) Transferring animals to Another Principle Investigator, (2) Transferring animals to another Animal Use Protocol, (3) Transferring animals to another account.
- D** Convenience fee is a charge for services or other activities which must be executed within twenty-four (24) hours of the initial approved and confirmed service request. Requester must complete Services Request Form.

ANIMAL PROCUREMENT and QUARANTINE

Investigators should submit hard copies of the Animal Request Form to the URAR-LS main administrative office- C124 Life Sciences Building, or fax to 706-542-0149 by the deadlines below. Facility Supervisors cannot accept order forms. The Animal Request form is found at the following web site:

QUARANTINE CHARGES

Rodents shipped to our facilities from unapproved vendors are subject to QA charges. The total charge will include purchase of sentinel animals, processing and shipping of samples, and testing costs. The number of sentinels tested will depend on the number of imported research animals (2 sentinels for 10 cages or fewer, 4 sentinels for 11-20 cages, etc).

Minimum charge will be \$315.00 for 2 sentinels.
